Minutes for Meeting of 29 May 2019

At 1908 Hrs. Commander Evan Totten determined there was a quorum present, he declared VFW Post 4266 open for business, sufficient members present to hold Post elections.

5. **Recognition and Introduction of Guests.** Special guest State Commander Steve Konas was present and addressed the membership.
6. **Recitation of Section 230102 of the Congressional Charter:** Commander Evan Totten read this document to the members present.
7. **All Regular business is suspended.** Commander Totten declares the purpose of this Special meeting of Post 4266 is for the nominating, electing and installing of Post Officers.
8. Floyd Merenkov makes a motion that Post elections will be held by a show of hands instead of a secret ballot. That motion was seconded by Mike Tarby, motion is passed by voice vote of the membership.

12. No nominations are presented for the position of Junior Vice Commander. This position will remain Vacant until such time a member is willing to accept a nomination.
13. QM Brushaber is re nominated for the position of Quartermaster and accepts nomination for another term in office. No other nominations are made, Gerard Brushhaber, is our Post 4266 Quartermaster for another one year term in office.

- 14.** Bob White is nominated for the position of Chaplin and accepts nomination. No other nominations are made, Bob White is our new Post 4266 Chaplin.
- 15.** Mike Tarby is nominated for the position of three (3) Year Trustee and accepts the nomination. No other nominations are made, Mike Tarby, is now our new Post 4266 3 Year Trustee.
- 16.** Floyd Merenkov, automatically moves down to the position of two Year Trustee.
- 17.** David Seal, automatically moves down to the position of one Year Trustee.
- 18.** Commander elect Josh Eason, makes the following appointments:
 - Surgeon, Gerard Brushaber.
 - Adjuant, Bob White.
 - Service Officer, Floyd Merenkov.
 - Judge Advocate, David Seal.
